Dear Mr. Bryant,

As someone who had been on our mailing list for a period, you will be aware that we are a group that is dedicated to the establishment of polite British culture for all compatible European peoples in a manner which will see an improvement to our lives everywhere we are and will be in the future.

Unfortunately, in a society that values equal treatment of all views as having equal merit and offensive speech considered to be anything that isn't sanctioned at law, regardless of the merit of the views, there is bound to be some dissatisfaction with our activities of late.

It is my considered opinion that the law is in this respect very much an ass. There is such a thing as superior argument, superior intellect, superior advocacy that should in fact be given some credit and ultimately be allowed to win. This is how any good notion of justice can be entertained in any sort of a seeming sincere manner.

To tell me that Lady Bellamy should be made to wait in a hospital line in an emergency ward while some pygmy from the Congo moves ahead of her so that we can demonstrate to all that we are good chsitians is well, for lack of a better word, let me say asinine. And that is what I think of the hate laws you have on the books in this province. As it is intolerant to such views as mine. Which are superior to those that have drafted this bad law.

Not all bad, however, since the Canadian criminal law does say you can tell the truth, and that you can do so with the intent of eliminating hatred in the

long run. If this were to be honestly applied to my case, I would never have to fear retribution through the courts by those seeking to inflict evil on the good Irish folk I serve.

I am enclosing a CD of our material which has been sent out mainly over this past year. Our website has been in existence for some six years now and indeed that is when we undertook our first major ad campaign. This saw our message in most Canadian homes and abroad as almost every single publication we approached back then was glad to carry our message. For free although we did have to tender IOU's in the way of a "cheque".

In the past month, our advertisement (most current policy statement – see file on CD) has run across News Zealand, an upscale News outlet in Melbourne Australia and in such Canadian cities as Windsor and Sault Ste Marie and Nanaimo BC.

Our message is a Christianly one. People of European descent with the most supreme intelligence beauty and goodness should not be made to suffer given someone else's sense of what is fair to do with resources of their own. Not when that person deciding is fundamentally stupid. And that is the best word for current british wisdom, but most especially, of the Canadian mindset in this regard.

I think our activities should go unmolested. I am not aware of any complaints this year despite our very honest open and blunt message on what we consider the fair thing to do with the resources to be found on this earth. An equitable allocation to the best people based on their contributions. That's all we ask. That's all. That all.

I am enclosing a key for the safety deposit box at The Royal bank where we keep data on a computer medium known as a USB drive (about the size of a small lighter). This will save drilling holes should you decide to see any more files we might release in the near future regarding our views.

A copy of this letter is being directed to the Toronto chief of Police Mr. William Blair, so that he may instruct the Hate Crimes Unit to take their cue from your office in this case. We are preachers of the good word and wish to be accorded some respect. Thank you,

I am a Canadian living in Australia for the winter. I read today's page 12 advertisement in <u>The Age</u> with shock and dismay; embarrassed to think these notions might be mistaken for Canadian ideals. I have several concerns:

- 1) What is this poorly written opinion piece on Canadian immigration policy doing in an Australian newspaper?
- 2) The entire document is based on a false notion, obvious in the first line. The British, and other western European people are *not* the "founding cultures and peoples of Canada". I encourage Mr. Chessman to read some Canadian history; the founding people of Canada are the various First Nations people that have been on the land since 'time immemorial'.
- 3) This document is racist and socio-economically prejudiced, and goes against the very ideals that make up Canada, which include the idea that people of any race or class are welcome to attempt to make a life in Canada, if they so desire or feel the need.
- 4) As for turning away from 'blind justice', the dangers of *biased justice* are many, as we can witness in many countries around the world. Our rights to justice, mobility and freedom of belief and expression are protected in the Canadian Charter of Rights and Freedoms.
- 5) On behalf of friends and co-workers, and the students I teach, not all of who are of western European descent, I take offence that only people of certain ethnic or economic backgrounds should be allowed into our country.
- 6) Many Canadians are not necessarily concerned with 'Christianly' thinking. Many practice different forms of spirituality and religion (also protected in the Charter of Rights and Freedoms), but I would daresay that most are concerned with right thoughts, right speech and corresponding actions.

Canada's strength is its diversity and tolerance, even though sometimes we stumble and have to reassert the ideal through public debate and discussion. I am horrified to think that your article might be mistaken as a reflection of Canadian ideals or policy.

I have made every attempt to understand your position, including visiting your website. If I have misinterpreted you I apologise.

And to the editor of The Age, please check into your sources of revenue before allowing a racist to advertise in your paper. (Peruse the website printed at the bottom of his page.)

I once defined racism as "that which is involved when someone seeks(indeed demands) an opportunity not on the basis of merit, but rather on the basis of having colored skin". This was on an interview I did in Canada back in 1999 on a Manitoba wide talk show on CJOB radio.

I now simply point to the obvious. EVERYONE is a racist, in that we ALL have a sense of racial identification. We are all born with this. We have an idea of who it is we belong with who we identify with who we protect who we care for who we relate to etc, all based on race. I believe what you mean by racism is the exercise of such thought on the part of any person of european identification. The word is applied to these peoples in particular only because of acknowledged superiority in this respect. God was not fair. In the areas of beauty, of intelligence and the ecercise of faculties which allow for artful expression, the most brialliant form of christianly good thinking, the ability to do whats best for these people who have merit to deserve the best of all, in this respect, Euros are supreme. We therefore deny them this ability to exercise their ability to think freely rationally and justly by using labels that make them feel euqal to the blacks, insiand and oriental whom you represent with your outburts on racism.

Aborigines lived in Australia and Canada before the arrival of civilization. So did cavemen, Im sure whats your point?

The fact that many religions exist, that many "peoples" exist, that many notions of justice are out there and that many bad laws are on the books, this does not make them valid.
